TOWN OF BRUNO

BYLAW #21/2019 A BYLAW TO CONTROL THE REMOVAL OF SNOW FROM PRIVATE PROPERTY

The Council of the Town of Bruno in the Province of Saskatchewan enacts as follows:

- 1. This bylaw shall be referred to as the Snow Removal Bylaw.
- 2. In this bylaw:
 - a) "Municipality" shall mean the Town of Bruno.
 - b) "Public Place" shall mean all or any part of a street as defined by *The Municipalities Act*, a park, a municipal reserve, environmental reserve, buffer strip, drainage ditch, or any other property owned by The Town of Bruno.
- 3. No person shall push, blade, shovel, blow or place snow that has accumulated on private property onto a sidewalk, street, or public place.
- 4. The owner or occupant of any property shall ensure that when clearing or removing snow, ice or other debris, that he or she shall refrain from causing damage to the sidewalks, streets, public place or any property of the Town of Bruno.
- 5. The owner or occupant of any property shall ensure that when clearing or removing snow, ice or other debris, that he or she shall refrain from using any salt or salt-based product on any sidewalk owned by the Municipality.
- 6. The owner of occupant of any property shall ensure that snow disposal or removal be undertaken in such manner that it does not create a hazard or interfere with the use of sidewalks, streets, or public places.
- 7. Contravention of this Bylaw may result in the Town of Bruno, by written order, to require the owner or occupant to remove the snow, ice, or debris from the street, sidewalk or public place.
- 8. The Town of Bruno may undertake actions or measures necessary to remedy the contravention of the Bylaw, including removal of the accumulation and invoice such costs to the property owner. Unpaid invoices shall be added to the owner's tax roll.
- 9. Any damages caused to Municipal streets, sidewalks or public property by snow, ice or debris removal shall be the responsibility of the property owner and any repairs that may be needed shall be the owner's responsibility. Any repairs carried out by the Town of Bruno in relation to the damages shall be invoiced to the property owner. Unpaid invoices shall be added to the owner's tax roll.

10. Any person found guilty of a breach of any of the provisions of this Bylaw shall be liable on summary conviction to the fines as stated below:

a) First Offence

\$100

b) Second Offence

\$200

c) Third & Subsequent Offences

\$500

d) In addition to any fines, the cost of removing the accumulation from the street, sidewalk or public place will be added to the property taxes of the individual or business, if removal is required.
